

The second part of this session will be given by Christine Ash, Deputy Water Division Director in Region 2. She will describe the extraordinary city, county, state and federal partnership that enabled Newark, New Jersey to avoid becoming another Flint, Michigan, after alarming levels of lead in drinking water were found in homes. Every level of government quickly stepped up to help address the problem -- providing bottled water and point-of-use filters, engaging in extensive public outreach, researching the source of the problem and the efficacy of the filters, and financing and implementing a highly accelerated program of lead service line replacements.

Patric McCoy – Artist, Art Appreciator and Environmental Enforcer

A group of five EPA Region 5 alums and two guests ventured to Patric McCoy's (Air Enforcement alum) apartment in the Bronzeville neighborhood on the mid-south side of Chicago in late April 2024 to view his large collection of art created by Black artists, mostly from Chicago. The artwork fills the walls, ceilings, and every nook and cranny of his two bedroom, two bath home.

It is nothing short of spectacular. He has organized the works around his many interests and themes, including music, cycling, altered states, sensuality, struggles and successes. His focus is on the black experience. It is easy to be overwhelmed by the scope and detail of the art, but Patric's patient, thoughtful guided tour gave us all a deep appreciation for how special he is as well as his passion for art.

Patric gained his interest in art from his father who was an accomplished artist going back to his high school days when he was accepted for studies at the Art Institute of Pittsburgh, only to have that withdrawn when they learned he was Black. Patric is a skilled photographer in addition to his outstanding career as an expert in continuous emission monitoring and air enforcement, where he was recognized with several gold, silver, and bronze medals for his excellence.

In addition, President Biden recognized Patric with a lifetime achievement award for his volunteer services. Patric provides tours to many students and groups to broaden their understanding of art. He has created a trust so that his collection will be maintained and available in perpetuity.
