



## Message from the President

I know all of you have been as concerned as I have been to watch critics of EPA in the Congress and the public become more vocal in the past few years. Even more disturbing is the increased frequency with which these criticisms are incorporated in proposed legislation or other actions that are designed to hamstring the Agency and prevent it from carrying out its statutory responsibilities.

No agency is perfect, but I have felt that most of these criticisms are unfounded and some are intentional distortions of EPA's actions and *potential* actions. Most of us are no longer at EPA and aren't in a position to address these criticisms on behalf of the Agency, but that doesn't mean that we don't still care.

Are there things we as alumni can do to counter these attacks or help EPA weather them? Some of us within the Association have been asking that question more frequently recently, and I would like to reach out to all of you for your ideas of how we might help, individually or as an Association.

Among the ideas that some have put on the table for consideration are:

periods of adversity.

- Members can contact their representatives in Congress to emphasize the importance of maintaining adequate staffing levels at EPA and funding to implement environmental statutes.
- We can look for opportunities to talk about EPA programs and accomplishments in our own communities - drawing both on our own experiences and by using material on the EPA and EPA-AA web sites as resources. Similarly, we can use social media to post articles about the good things EPA is doing to protect the health and welfare of us all.
- Members can communicate with local newspapers and other media to explain environmental issues and EPA processes.

We can make an effort to disassociate EPA employees from those that govern at any particular time and focus on the scientific and technological breakthroughs that American industry teaming with EPA professionals have accomplished.




